

7 LIST OF AGENCIES FROM WHICH PERMITS ARE REQUIRED

Agency	Responsibilities, Permits, and Approvals
Federal Agencies	
National Marine Fisheries Service	Reviews and submits recommendations to USACE related to federal construction actions in accordance with the Fish and Wildlife Coordination Act. Responsible for Essential Fish Habitat (EFH). Provides EFH information, reviews federal action potential effects on EFH, and provides conservation recommendations to USACE. Responsible for Marine Mammal Protection Act (MMPA) and reviews federal action potential effects on marine mammals and provides conservation recommendations to USACE.
U.S. Army Corps of Engineers	Lead federal agency for navigational improvements and permitting authority for construction in navigable waters and dredged material placement.
U.S. Fish and Wildlife Service	Reviews and submits recommendations to USACE related to federal construction actions and issuance of permits in accordance with the Fish and Wildlife Coordination Act and consultation pursuant to Section 7 of the Endangered Species Act (ESA).
U.S. Coast Guard	Has jurisdiction over marine facilities, bridges, and vessel transportation in harbor waters. Responsible for ensuring safe navigation and for preventing and responding to oil or hazardous materials releases in the marine environment.
U.S. Federal Railroad Administration	Reviews and approves changes in rail trackage, connections, signage, and bridges.
U.S. Environmental Protection Agency	Reviews and submits recommendations to USACE related to federal construction actions and issuance of permits. Regulatory authority for determining suitability of dredged sediments for placement. Primarily responsible for implementing the Clean Air Act and works with other federal agencies to implement conformity requirements. Reviews and submits recommendations for Spill Prevention Control and Countermeasure (SPCC) Plans for non-transportation-related onshore and offshore facilities engaged in storing, processing, refining, transferring, distributing, or consuming oil and gas products.
State Agencies	
Bay Conservation and Development Commission	Reviews document to ensure compliance with the Coastal Zone Management Act (CZMA) and consistency with the California Coastal Act; also performs a federal Consistency Determination.
California Department of Fish and Game	Reviews and submits recommendations in accordance with CEQA related to potential project impacts on state fish and wildlife.
California Department of Transportation	Permitting authority for rail trackage, connections, and signage during construction operations.
California Office of Historic Preservation	Consultation under Section 106 of the National Historic Preservation Act regarding impacts on cultural resources (e.g., demolition of buildings and structures) that are either listed, or eligible for listing, on the National Register of Historic Places.

Agency	Responsibilities, Permits, and Approvals
California Public Utilities Commission	Permitting authority for rail trackage, connections, crossings, and signage during construction operations.
State Lands Commission	Dredging and dredged material placement activities in state tidelands.
California Waste Management Board	Statutory and regulatory authority to control the handling and disposal of solid, non-hazardous waste in a manner that protects public safety, health, and the environment. State law assigns responsibility for solid waste management to local governments. Solid waste requiring disposal will be generated from the demolition of existing wharves.
State Water Quality Control Board, San Francisco Bay and Central Valley Regions	Permitting authority for waste discharge requirements for discharges that might affect surface water or groundwater, including review under Section 401 of the Clean Water Act, and issuance of National Pollutant Discharge Elimination System (NPDES) permits for discharge of wastewater into surface waters.
CALFED Bay-Delta Program	Coordinates activities and interests of the state and federal governments to focus on interrelated water problems in the Sacramento-San Joaquin River Delta (Delta). Priorities include ensuring reliability of water supplies within the Delta, improving the Delta's water quality, restoring the Delta's ecosystem and improving levee protection along the Delta's rivers.
California Department of Water Resources	Responsible for the management and regulation of water usage.
Regional Agencies	
Bay Area Air Quality Management District	Permitting authority within the nine San Francisco Bay Area counties for stationary and area sources for construction of landfill and operation of pump stations, storage tanks, and terminal facilities; for approving emissions from construction and operation of emission-producing equipment; and for regulating air toxics and other air quality nuisances.
Yolo-Solano Air Quality Management District	Permitting authority within Yolo and most of Solano counties for stationary and area sources for construction of landfill and operation of pump stations, storage tanks, and terminal facilities; for approving emissions from construction and operation of emission-producing equipment; and for regulating air toxics and other air quality nuisances.
Sacramento Metro Air Quality Management District	Permitting authority within Sacramento County for stationary and area sources for construction of landfill and operation of pump stations, storage tanks, and terminal facilities; for approving emissions from construction and operation of emission-producing equipment; and for regulating air toxics and other air quality nuisances.
Association of Bay Area Governments	Comprised of 99 of the 101 cities within the San Francisco Bay Area and responsible for developing regional plans for transportation management, housing, land use, environmental quality, and economic development in the San Francisco Bay area.
Delta Long-Term Management Strategy	Facilitates development of a long-term management approach for dredging and dredged material management actions within the Delta based on science, enhanced coordination among the stakeholders, and issue resolution.

Yolo, Sacramento, Solano, and Contra Costa Counties	Permitting authority for all county permits for building and grading, critical areas, storm drain connections, discharges of stormwater, and water discharges to the wastewater collection system and for approval of street vacations, zone changes or amendments, or changes in county road design, construction, signalization, signage, and traffic counts.
City of West Sacramento	Permitting authority for all city permits for building and grading, critical areas, storm drain connections, discharges of stormwater, and water discharges to the wastewater collection system and for approval of street vacations, zone changes or amendments, or changes in city street design, construction, signalization, signage, and traffic counts.
